Applications are invited for admission to 1st Semester B.Com. (Honours) Course (Morning and Day Sections) under the University of Calcutta for the Academic Session 2020 - 2021.

◆Eligibility Criteria:

1. Passed 10+2 Examination or its equivalent in 2020 and preceding 5(five) years i.e. upto 2015 with at least five subjects of 100 marks each including English and any one of the following related subjects, viz.,

Accountancy, Business Economics including Business Mathematics, Business Organisation, Mathematics, Business Mathematics, Economics, Statistics, Business Studies, Office Practice and Secretarial, Financial Accounting, Elements of Cost Accountancy and Auditing, Book Keeping, Commerce, Cost Accountancy & Principle of Management, Commercial Law and preliminaries of Auditing, Costing and Taxation.

2. Secured the minimum marks as indicated below:
 - i. **For General category candidates:** 75% in aggregate and 60% in the related subject.
 - ii. **For OBC-A and OBC-B Candidates of West Bengal only:** 67.5% in aggregate and 54% in the related subject.
 - iii. **For SC/ST Candidates of West Bengal only:** 56.25% in aggregate and 45% in the related subject.
 - iv. **Seats are reserved for persons with disabilities in each category as per government rules.**

Clarification relating to Point No. 2

Aggregate Percentage of marks is to be calculated by considering the best marks obtained in the four subjects excluding the compulsory Environmental Education / Studies. If any of the subjects (Environmental Education/Environmental Science/Environmental Studies) is studied as an Elective subject of 100 marks, it may be taken into account for the purpose of determining aggregate marks.

◆Selection Procedure: Selection of candidates will be made strictly on the basis of merit.

List of selected candidates will be displayed in our admission website. However, they will also be allowed to exercise their choice for Day or Morning section, subject to availability of seats, at the time of submission of fees online after uploading of scanned testimonials.

◆Issue and Submission of Forms:

The Application Form will only be available online. Candidates are advised to fill in the Application Form electronically (online). **In no case, filled-up forms will be received by the office of the College.** For electronic submission of the Application Form log onto the Admission Website of the College www.goenkacollegeadmissions.com. Candidates will have to deposit online processing fee (non-refundable) of **Rs. 50** (Plus Bank Charges as applicable) in Debit Card/Credit Card/Net Banking to the Bank Account **No.128801000689 (IFSC Code: ICIC0001288) of ICICI Bank. (Name of Account: GOENKA COLLEGE OF COMMERCE AND BUSINESS ADMINISTRATION).**

Online application fees in cash will be accepted only on 19.08.2020 at the ICICI BANK (only at Bowbazar Branch, Kolkata during banking hours).

Important Points Relating to Provisional Merit List and Admission

1. If any listed candidate fails to deposit the fees online within the scheduled time, he/she will not get any further chance of admission in this college. Any request for admission due to non-submission of admission fees online will not be entertained.
2. All admissions are provisional. Applicant will be treated as bonafide student of the college subject to verification of original documents after the commencement of 1st Semester class.
3. Applicants must note that after admission no interchange between Morning Section and Day Section is allowed.
4. The selected students must submit the following declarations at the time of verification:
 - (i) for attending classes regularly
 - (ii) for abiding by the anti-ragging regulations of the institution.
5. All applicants must note that college follows a very strict stance regarding class attendance.
6. **Caste certificate issued by states other than the state of West Bengal will not be eligible for getting the reservation facility.**
